Dear Sir,

It is submitted for your kind consideration that, in continuation of the Election process of Pakistan Solar Association and pursuant to the applicable provisions of the DGTO Rules and in furtherance of a transparent and duly compliant election process, the Election Schedule 2026 - 2028 has been prepared and subsequently approved by Executive Committee members.

A meeting of the Executive Committee has been convened today, 13 July 2026 at 06:00 PM Pakistan Standard Time through teams / online mode, to review and approve the proposed Election Schedule 2026 - 2028. The list of the participants is hereby attached as Annexure – A for your information and further necessary action.

The proposed Election Schedule is annexed hereby as Annexure-B which has already been approved during the aforementioned meeting. Upon approval, the Secretary General may be authorized to display and submit the approved schedule in strict adherence to the DGTO Rules.

The relevant sub-clauses, mandatory timelines and procedural requirements prescribed under DGTO rules are hereby reproduced for your reference and further necessary action:

Rule / sub-clause	Description
Rule 13(b)	<i>Elections of trade organizations other than the Federation are to be held during July to September of the election year.</i>
Rule 14(1)(b)	<i>For all trade organizations other than the Federation, the election schedule is to be approved/issued in the first half of July.</i>
Rule 14(2)(a)-(c)	<i>Within two days of approval, the schedule is to be displayed at the head/regional office notice boards, displayed on website, and submitted to the Regulator.</i>
Rule 18(19)(b)	<i>Final results are to be announced in the AGM within the prescribed period and not later than 30 September for trade organizations other than the Federation.</i>

Rule / sub-clause	Description
Rule 18(21)(a)-(c)	Final election results announced in the AGM are to be displayed within two days and submitted to the Regulator within seven days.

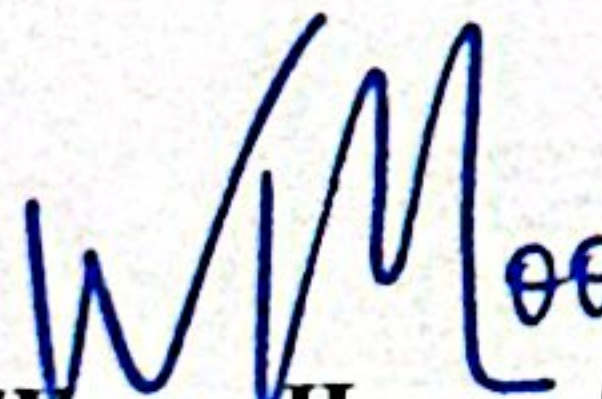
Resolution:

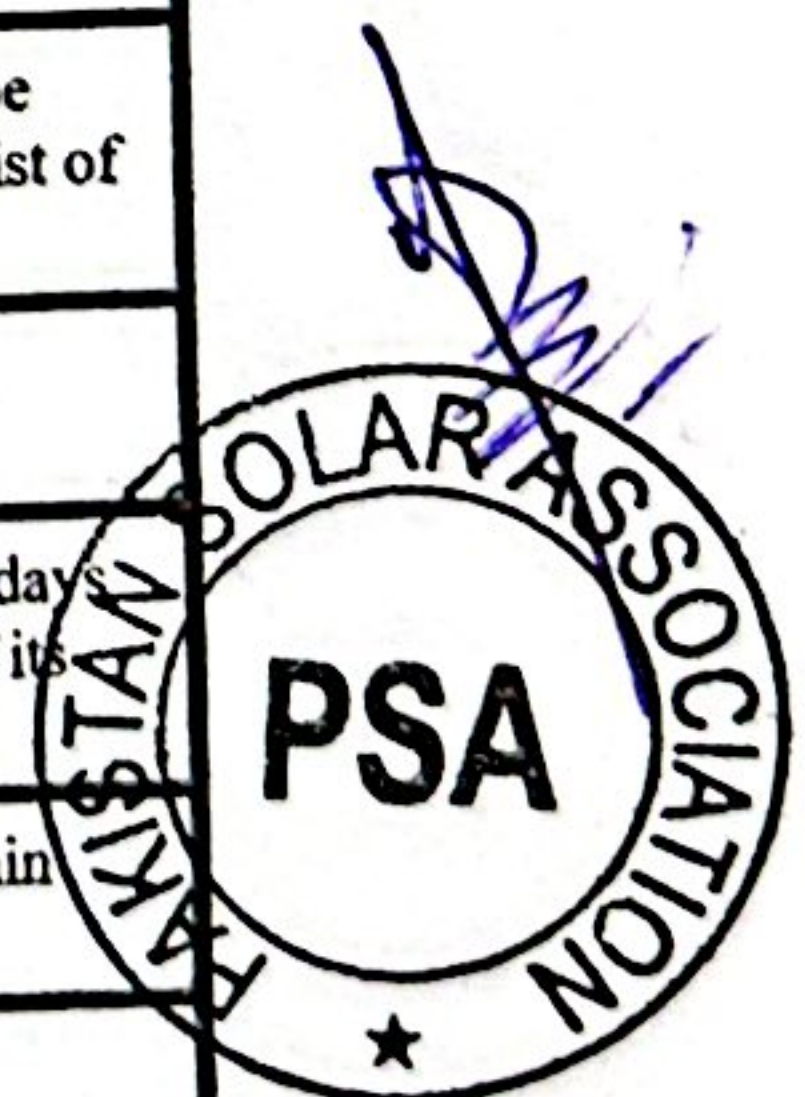

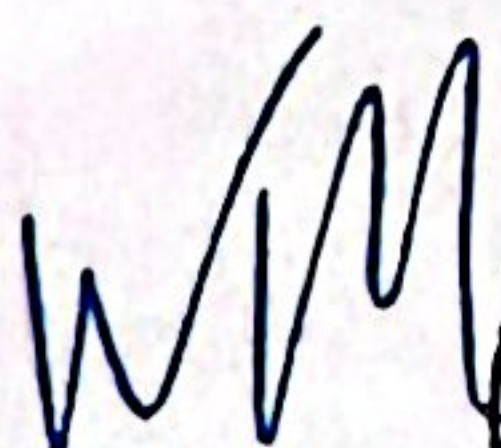
