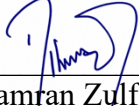

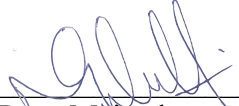

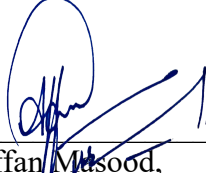
The Election Commission shall consider and decide any objections received within the prescribed period in accordance with the applicable Rules and Election Schedule.
