IMPORTANT NOTES [DGTO R.18, R.21 | PSA AOA Arts.25, 27]

- [DGTO R.21(4)-(5) | PSA AOA Art.27(c)-(d)] This form applies to regular Executive Committee seats elected by the General Body from the Corporate and Associate Classes.
- [DGTO R.21(6) | PSA AOA Art.27(c)] The two seats reserved for women entrepreneurs are additional seats under Rule 21(6) of the Trade Organizations Rules, 2013, as amended, and are elected by the Executive Committee under the applicable procedure.
- [DGTO R.18(9) | PSA AOA Art.25(9)] The nomination must be signed by the candidate and duly proposed and seconded by duly registered voters, and must be submitted within the period prescribed in the approved Election Schedule / Rule 18(9).
- [DGTO R.18(11)-(14) | PSA AOA Art.25(11)-(14)] Submission of this form does not by itself establish eligibility. All nominations remain subject to scrutiny, objections, representations/appeals and final decision under the applicable Rules.

Legal reference note: Nomination procedure is governed principally by PSA AOA Arts.22–27 and DGTO Rules 15–21. The PSA MOA does not prescribe a separate nomination procedure. Where any AOA provision conflicts with the Trade Organizations Act/Rules, the applicable statutory provision prevails as stated in the PSA AOA immediately before Art.27.
