

**REJECTION OF NOMINATION PAPER – ELECTION OF EXECUTIVE
COMMITTEE, PSA TERM 2026–2028**

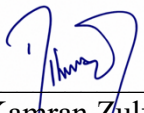
In pursuance of the applicable provisions of the **Trade Organizations Act, 2013, the Trade Organizations Rules, 2013, as amended from time to time, the Memorandum and Articles of Association of Pakistan Solar Association**, and the duly approved Election Schedule for PSA Elections 2026 – 2028, the nomination papers received for election to the Executive Committee were taken up for scrutiny by the Election Commission on **27th August 2026**.

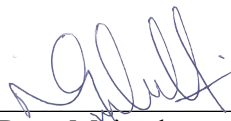
Upon examination of the nomination papers, supporting documents and the relevant record maintained by the Association, certain nominations were found not to be in conformity with the applicable eligibility, procedural and documentary requirements governing the election process.

Accordingly, after due scrutiny and consideration of the available record, the Election Commission has rejected the nomination papers identified in **Annexure-A attached hereto**, together with the respective grounds / observations forming the basis of such decisions. The names appearing in Annexure-A shall therefore not form part of the **Provisional List of Candidates** issued following scrutiny of the nomination papers.

Any objection against a decision relating to nomination may be submitted within the prescribed period in accordance with **Rule 18(12) of the Trade Organizations Rules, 2013**, followed by such further remedy as may be available under **Rule 18(13)** and the approved Election Schedule.

This Notice, together with **Annexure-A**, shall form part of the official election record of Pakistan Solar Association and is being issued for information, record and further necessary action in accordance with the applicable election procedure.
